Summary of the Proceedings of 36th Annual General Meeting of the Company

The 36th Annual General Meeting of Zenith Exports Limited ("the Company") was held on Thursday, September 25, 2018 at 11:30 a.m. at the Ground Floor, Auditorium of Birla Academy of Art & Culture, 108, Southern Avenue, Kolkata-700 029.

The Meeting commenced at 11:30 A.M. with the speech of Mr. Surendra Kumar Loyalka, Chairman cum Managing Director of the Company and he chaired the proceedings of the Meeting before the shareholders.

The requisite quorum being present, the Chairman called the meeting to order.

The Chairman addressed the Members. The Chairman read out the speech to the members as a part of the Annual Report.

Pursuant to the provisions of section 108 of the Companies Act'2013 read with Rule 20 of the Companies (Management and Administration) Rules'2014 and applicable provisions of the SEBI (Listing Obligations Disclosure Requirements) Regulations'2015 with the Stock Exchanges, the Company has engaged the services of NSDL to provide Remote Electronic Voting ("e-voting") facility to all the members to enable them to cast their votes electronically in respect of business of 36th Annual General Meeting of the Company.

The Company has appointed Mr. Asit Kumar Labh (Membership No. 32891), ACS, Practicing Company Secretary, as the Scrutinizer for conducting the Remote e-voting Process/ Physical Ballot of 36th AGM in fair and transparent manner. The E-voting platform was opened from 9:00 a.m. on 22th September'2018 to 5:00 p.m. on 24th September'2018.

The members who have not casted their vote through Remote E-voting have casted their vote by Physical Ballot Paper, after collection from the Officials of M/s. C. B. Management Services Private Limited, Registrar & Transfer Agents of the Company at the entrance. Ballot Paper duly filled-up & signed by the members may be deposited with Registrar & Transfer Agents in a sealed Ballot Box.

The Combined Results of E-voting & Physical Ballot Poll shall be declared on Thursday; 27.09.2018 at the Registered Office of the Company & a copy shall be placed on the Company's Notice Board and posted on the website of the Company & NSDL.

4. Appointment of Mr. Varun Kumar Loyalka (07315452), as Joint Managing Director. **(Ordinary Resolution)**
